

## **FACTS** WHAT DO MAF LEASING AND AMERITRUST AUTO LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	<ul> <li>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</li> <li>Social Security number and income</li> <li>Account balances and payment history</li> <li>Transaction history and employment information</li> </ul>	
How?	All financial companies need to share customers' personal information to run their everyday business. How do MAF Leasing and AmeriTrust Auto, LLC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings and limited access to your information by employees.

Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>Sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</li> </ul>			
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>MAF Leasing and AmeriTrust Auto, LLC are affiliates. Our other affiliates include AmeriTrust Financial Technologies Inc. and Powerband Solutions US Inc.</li> </ul>			
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Nonaffiliates we share with can include account servicing companies, insurance companies, direct marketing companies, and automobile dealers.</li> </ul>			
Joint Marketing Other important information	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include financial companies and automobile dealers.</li> </ul>

We will not share your personal or financial information with affiliates or joint marketing companies if you instruct us not to as described in the "Important Privacy Choices for Consumers" provided with this notice.
